# SPECIFIC TERMS AND CONDITIONS

#### SMOKING

Smoking is prohibited during the program in places where the laws of the country specified. Similarly, you cannot smoke in the home of the host family, or in the facilities of the residences

PURCHASE, POSSESSION OR CONSUMPTION OF ALCOHOLIC BEVERAGES: Students of the Fundación de la Lengua Española cannot consume or purchase alcoholic beverages under any circumstances. Purchasing, possession or consumption of alcohol are grounds for immediate expulsion from the program.

# DRUGS CONSUMPTION OR NONPRESCRIPTED MEDICINES COMSUMPTION

ession of drugs or drugs not prescribed by a doctor, in which case it will be a cause for immediate dismissal from the program. It is strictly forbidden to use or be in posse

### ATTENDANCE, ACTIVITIES AND EXCURSIONS:

Class attendance, activities and excursions are mandatory. The student may be absent due to good cause and with the express permission of the program coordinator and the Spanish monitor

#### VANDALISM OR THEFT:

Any act of vandalism (graffiti drawing, writing on tables, material damage, making fire, etc.) On private property or public places is illegal. The participant shall bear all costs for the repairmen or replacement generated from this practice

Any theft / robbery, even small its value, is punished by the immediate expulsion of the student from the program.

# TRIP

Participants can not make trips out of the area where the course is offered, except those programmed by the Fundación de la Lengua Española, unless these are organized by the host family and authorized by both destination and coordination by the natural family.

#### DRIVER

It is absolutely forbidden to drive motor vehicles, including motorcycles and vehicles needed for the countryside. Whenever the student travels by a motor vehicle (as a passenger) has to use a seat belt.

# BACK TO COUNTRY OF ORIGIN:

The student has to return to their country of origin with their group or individually, at the end of the program, unless the Fundación de la Lengua Española receives indication and permission of the natural parents informing about other plans.

## OTHER PROHIBITED CONDUCT:

Except express authorization, students of the Fundación de la Lengua Española are prohibited to have piercings and tattoos done during the program. In those legally established premises, people underage require parental consent, but there are many places which do not meet current regulations and further sanitation and hygiene controls are non-existent

Health insurance does not cover any condition arising from these practices. Similarly, it is forbidden to have sex during the course of the program.

# DISCIPLINE AND REMOVAL PROGRAM:

Any case of indiscipline, misconduct and violation of these rules may be cause for immediate dismissal from the program. In this case, the legal representative agrees to bear all expenses for their early return to Spain.

#### INSURANCE, ACCIDENT, AND BAGGAGE LIABILITY:

All students will travel insured by their parents being responsible for hiring such insurance, in the country of origin or directly at the Fundación de la Lengua Española, having been given such insurance coverage prior to departure (to the parents or to the Foundation in each case). Any expenses not covered by insurance are borne by the parents or legal representative of the participant.

# HOST FAMILIES (only for family programs):

1. The student must be grateful to the host family at all times to respect their way of life and their customs and adapt to them. Differences of race, religion, and family structure, educational level, etc. will be found, learning how to appreciated them. Do not forget that these are part of the experience, contributing to enrich their education and help them to mature

2. The participant is not a guest and family welcomes you as a member. You must participate in household task to the same extent as other family members.

3. In the family, the student is responsible to deal with the extra expenses, which may appear, such as for example using the telephone

4 It should be noted that there may be families' cancellations at the last minute for various reasons. In this case the participant will be assigned to another family.

5. There may be circumstances in which the student has to change his family during their stay, being this change duly communicated to parents.

6. The student must participate in family activities and meet other students in classes, trips and planned activities, as long as the family has no other organized activity.

7. Do not use the host family phone, unless it is an emergency.

8. The student must abide by all rules established by the family, as far as schedules, habits and behaviour concerned. You may not invite friends home without the permission of the family. If within the program established by the Fundación de la Lengua Española a change of plans or schedules is established the student must report to the family.
